

Club Quilton Promotion 2019/2020

Conditions of Entry

1. Information on how to enter & prizes form part of these terms & conditions. Any entry not complying with these terms and conditions is invalid.
2. Entry is open to residents of Australia. Employees & their immediate families of the Promoter, the Promoter's associated companies and agencies are ineligible to enter.
3. If an entrant is under 18 years of age, they must obtain their parent or guardian's consent to enter the promotion on these Conditions of Entry and whose parent or guardian has agreed to these Conditions of Entry.
4. To enter entrants must within the promotional period log on to quilton.com.au and complete all the required fields and submit their entry. Each draw period will commence at 12.01am on the draw period start date, and will close at 11.59pm on the draw period close date, as outlined in condition 8. The winners will be notified by phone and in writing within 2 business days of the draw, and their names will be published on quilton.com.au for a period of 28 days on the dates outlined in the table in condition 8.
8. The first valid entry drawn in each draw will receive a 'year's supply' of Quilton 3 ply Toilet Tissue, to a maximum of 208 rolls.
