

Club Quilton Win a Year's Supply Promotion 2022/2023 Conditions of Entry

- 1. Information on how to enter & prizes form part of these terms & conditions. Any entry not complying with these terms and conditions is invalid.
- 2. Entry is open to residents of Australia. Employees & their immediate families of the Promoter, the Promoter's associated companies and agencies are ineligible to enter.

Each draw period will commence at 12.01am on the draw period start date, and will close at 11.59pm on the draw period close date, as outlined in condition 8. The winners will be notified by phone and in writing within 2 business days of the draw, and their names will be published on quilton.com.au for a period of 28 days on the dates outlined in the table in condition 8.
